## **Red Cross EOC Station, W4ARC**

The Louisville Area Chapter EOC station, W4ARC, now is fully operational. W4ARC is the primary amateur radio communications link for the Louisville Area Chapter for Jefferson Co (KY) and the surrounding counties in Southern Indiana and Kentucky. The station equipment is located in the Emergency Operations Center of the Chapter at 510 East Chestnut. Given the RF "hole" in the downtown area the capabilities at this location are limited, by design, to VHF/UHF FM and packet.

A Yaesu FT-7900R/Diamond X510HDM is for 144 MHz/440 MHz FM and an Alinco DR-130/KPC 3+/Diamond X510HDM is for packet and a backup for 144 MHz FM. Both antennas are located on the roof of the building.

The digital station is operational as an RMS Server Gateway (W4ARC-10) and also as a KA-Node (W4ARC-7) on 145.050 MHz. The Winlink E-mail is W4ARC@winlink.org.

Further testing is to take place on peer-to-peer connections in the area that could be used if the Internet is unavailable or a secure communications link needs to be established. If you have digital capabilities please try to connect to this station and report your results to Paul Kern at <a href="https://www.wya.needs.com"><u>W4ARC@aol.com</u></a>.

The Oldham County Kentucky Amateur Radio Emergency Service (ARES) is an all volunteer group of licensed amateur radio operators who have

registered their qualifications and equipment and undergone specialized training for emergency communications duty during natural or man-made disasters.

We also offer our communications services free of charge to community events around the area such as walks, runs and bike rides, parades and other gatherings. We use these events as a training opportunity and a way to educate the public about amateur radio.

Every licensed amateur, regardless of membership in ARRL or any other local or national organization is eligible for membership in ARES. The only requirements are possession of an amateur radio license, some basic training, and a sincere desire to serve.
